

"...well funded political operatives or reporters wouldn't be able to dig it up?" (a different original BC). Besides the inexplicable movable layers of the PDF, what we are made curious by is what we don't know, what we haven't seen, answers that haven't been given, such as "why did the President not show the original birth certificate that he inherited from his mother?" He mentioned it in his biographic book. He must still have it. But, by not showing it, he is seen as not wanting to show it for some unknown reason, a reason that may have to do with his eligibility to be the President.

Or "Why doesn't he allow the public, including experts, to view the hard-copies that Hawaii states they provided him?" The suspicion remains that he deliberately wants to hide some fact from the American people. Whatever it is, reasonable curiosity needs to be satisfied. And it isn't being. Has anyone heard an explanation from the White House as to the origin of, or any details at all about, the PDF? Nothing has been explained about it. It's purpose was to clear the air, yet too much "unclearness" remains. Why? Because their tactic was to end the suspicions and questions on the day that it was released and never refer to it ever again. So far that tactic has been totally successful. And that might never change, at least as long as he wears the mantle of the Presidency. Only the internet and awakened public curiosity can change that.

From a common sense intuitive view of President Obama's remarks at the press briefing one would have had to be an innocent child to not be disturbed by what he asked and how he asked it. He, in the past, had linked the White House web-site to a fake Certification of Live Birth digital document image that certified nothing and was created on a computer, not by a scan of a real paper document. Then after blocking every attempt to see the original birth certificate, presto!! Here it is! But let's not dwell on it, no no, lets move beyond it, let's forget about it, lets not even think about it anymore. There's nothing to see here, just move along.

The PDF (Portable Document Format) is an altered image of a digitized document. The smoking guns I've shown do not directly related to changing the place of birth, but any evidence of falsification/alteration can only be assumed to be rare instances where the manipulator made small mistakes that were detectable with very close examination. Since most, or all, of the text was originally in a single layer with an invisible back-ground, like text on celluloid, any entry could be easily erased and something substituted in its place with out disturbing any of the image of the original paper page since it had been deleted (in the Records Department's digitization process) in order to save on memory and reduce the file size considerably. When that digitization took place RAM and hard drive capacity was much smaller and much more expensive, and also, computers were much slower.

The image used to create the PDF was the product of the digitizing of the Hawaiian birth records so they could have digital backups, which could be shared with authorized Federal agencies, (and could be printed on an official-looking background in place of the white paper of the original form.

The statements of the Hawaiian officials reveal one of two possibilities. Either the original unaltered birth document states Hawaii as the birth location, as they claim, or it has been altered in its digitally form to state that. That would either have been done in Hawaii or by someone connected to the White House. Assuming that their statements that Obama was born in Hawaii are false, then it would follow that if they were willing to lie for him, then they would also be willing to facilitate the falsification of their "digital abstract record"/image, while leaving the original hard-copy untouched.

The PDF would not be possible without access to images of original Hawaiian birth certificates. Since he has never shown any Hawaiian hard copies to the public, (nor even the one he would have inherited from his mother), one must assume they show something different from his PDF, or... they never existed and the whole story of producing and obtaining them is a complete fabrication concocted to cover the lie perpetrated by Hawaiian officials that long form certificates were no longer issued -though it is clearly required by law.

That lie is what allowed Obama to evade demands that he release the long form (since the short form was shown to be a counterfeit).
